Release and Waiver of Liability and Indemnity Agreement**

In consideration for programs and activities of the YMCA for any purpose, including, but not limited to observation or use of the facilities or equipment, or participation in any off-site program affiliated with the YMCA, the undersigned, for himself or herself and any personal representatives, heirs, and next of kin hereby acknowledge, agrees and represents that he or she has, immediately upon entering or participating inspect and carefully consider such premises and facilities or the affiliated program. It is further warranted that such an entry into the YMCA for observation or use of any facilities or equipment or participation in such affiliated program constitutes an acknowledgement that such premises and any facilities and equipment thereon and such affiliated program have been inspected and carefully considered and that the undersigned finds and accepts same as being safe and reasonably suited for the purpose of such observation, use of and participation.

**IN FURTHER CONSIDERATION OF BEING PERMITTED TO ENTER THE YMCA FOR ANY PURPOSE INCLUDING, BUT NOT LIMITED TO OBSERVATION OR USE OF THE FACILITIES OR EQUIPMENT OR PARTICIPATION IN ANY OFF-SITE PROGRAM AFFILIATED WITH THE YMCA, THE UNDERSIGNED HEREBY AGREES TO THE FOLLOWING:**

1. The undersigned hereby releases, waives, discharges and covenants not to sue the YMCA and all branches thereof, its directors, officers, employees, and agents (hereafter referred to as "releasees") from all liability to the undersigned, his personal representatives, assigns, heirs, and next of kin for any loss or damages and any claim or demands therefore on account of injury to the person or property resulting in death of the undersigned, whether caused by the negligence of the releasees or otherwise while the undersigned is in, upon, or about the premises or any other facilities or equipment therein or participating in any program affiliated with the YMCA.
2. The undersigned hereby agrees to indemnify and save and hold harmless the releasees and each of them from any loss, liability, damage or cost they may incur due to the presence of the undersigned in upon or about the YMCA premises or in any way observing or using any facilities or equipment of the YMCA or participating in any program affiliated with the YMCA whether caused by the negligence of the releasees or otherwise.
3. The undersigned hereby assumes full responsibility for and risk of bodily injury, death or property damage due to negligence of releasee or otherwise while in about or upon the premises of the YMCA and/or while using the premises or any facilities or equipment thereon or participating in any program affiliated with the YMCA.

The undersigned further expressly agrees that the foregoing release, waiver and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the State of Pennsylvania and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding continue in full legal force and effect.

The undersigned has read and voluntarily signs the release and waiver of liability and indemnity agreement, and further agrees that no oral representations, statements or inducement apart from the foregoing written agreement have been made.

(hereinafter referred to as JVYMCA)

## Climbing Wall Release/Indemnification of all Claims and Covenant Not to Sue

**NOTICE: THIS IS A LEGALLY BINDING AGREEMENT.** By signing this agreement, you give up your right to bring court action to recover compensation or obtain any other remedy for any injury to yourself (or your minor child listed on this agreement) or your property or for your death however caused arising out of your (or your child's) use of the JVYMCA Climbing Wall, now or any time in the future.

### Acknowledgment of Risk

I HEREBY ACKNOWLEDGE AND AGREE that the sport of rock climbing and the use of the Climbing Wall has *inherent* risks. I have full knowledge of the nature and extent of all the risks associated with rock climbing and the use of the Climbing Wall, including but not limited to:

1. All manner of injury resulting in falling off the Climbing Wall and hitting rock faces and projections, whether permanently or temporarily in place, or the floor;
2. Rope abrasion, entanglement and other injuries resulting from activities on or near the Climbing Wall such as, but not limited to, climbing, bouldering, belaying, rappelling, lowering on rope, rescue systems, and any other rope techniques;
3. Injuries resulting from falling climbers or dropping items, such as, but not limited to, ropes, or climbing hardware;
4. Cuts and abrasions resulting from skin contact with the Climbing Wall;
5. Failure of ropes, harnesses, carabiners, slings, runners, belay devices, anchor points, or any part of the Climbing Wall structure and hardware.

I further acknowledge that the above list is not inclusive of all possible risks associated with the use of the Climbing Wall and that the above list in no way limits the extent or reach of this release and covenant not to sue.

### Release/Indemnification and Covenant Not to Sue

In consideration of my use (or my child's if under 18 years of age) of the Climbing Wall, I, \_\_\_\_\_, the undersigned user (or parent/guardian of child listed below), agree to release and on behalf of myself, my heirs, representatives, executors, administrators, and assigns, HEREBY DO RELEASE JVYMCA, its officers, directors, climbing wall supervisor, instructors, agents, employees, and volunteers from any cause of action, claim, or demand of any nature whatsoever, including but not limited to, a claim of NEGLIGENCE, which I, my heirs, representatives, executors, administrators and assigns may now have, or have in the future against the JVYMCA on account of personal injury, property damage, death or accident of any kind, arising out of or in any way related to my (or my child's) use of the Climbing Wall whether that use is supervised or unsupervised, however the injury or damage is caused, including, but not limited to the NEGLIGENCE of JVYMCA, its officers, directors, climbing wall supervisor, instructors, agents, employees and volunteers. In addition, I agree to IDEMNIFY AND HOLD HARMLESS the JVYMCA, and its employees and volunteers from any and all causes of action, claims, demands, losses, or costs of any nature whatever arising out of or in any way related to my use (or my child's use) of the Climbing Wall.
